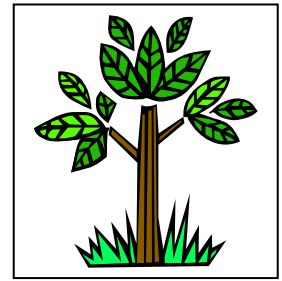


RED FORREST PUPPY/SALES CONTRACT



TERMS OF CONTRACT

_____ As a show and/or breeding quality animal with no disqualifying faults and full ASCA/AKC registration. We do not believe any breeder can guarantee a dog finishing a championship. All dogs go through a puppy stage, adolescence and adulthood, where many changes take place. We will do our best to select the puppy with the most potential. I do not guarantee ear set or herding instinct.

_____ As a companion animal with ASCA/AKC registration. This puppy will be spayed/neutered. If the puppy is a mismark or has any other disqualification according to the Australian Shepherd Club of America™ (ASCA™) breed standard upon birth, only limited registration papers will be given. (Limited registration entitles you to participate in most any dog sport and competition; it only affects the offspring.) Here at Red Forrest, we are one of the few breeders that offer a \$30 spay/neuter refund. In order to receive the refund, the spay/neuter needs to occur before the dog/bitch is 2 years of age. Please send us a copy of the surgery receipt. I do not guarantee ear set or herding instinct.

As a **show prospect**, Seller hereby guarantees that said dog is free from the following:

- Any disqualifying faults as listed in the Australian Shepherd Club of America™ breed standard. If said dog should develop a disqualifying fault which has not corrected itself by the attained age of (2) years, Seller retains the right to personally examine the dog or require a veterinary certified letter stating as such.

As a **show prospect or companion animal**, Seller hereby guarantees that said dog is free from the following:

- The canine disease of hip dysplasia. If said dog is found to be dysplastic, Seller requires a copy of OFA's official certification or from a veterinary stating such, \$100 refund will be given.
- Any hereditary eye defects. Seller is not held liable for any defects that occur or are revealed to the Seller after the age of 2 years. A \$50 refund will be given.
- Is diagnosed with canine epilepsy, hemangiosarcoma and autoimmune disease before the age of 3 years, I will replace the dog with a same sex/color unless Buyer/Seller agrees to a change.

If purchasing a "show quality" puppy, Seller has to re-determine in 1 year whether that puppy has retained the same "show quality" characteristics. If the Seller determines that the dog is still of breeding quality, the Buyer shall have the option to breed the dog when it reaches the commonly accepted age of breeding, which is 2 or more years old. Buyer agrees he/she will not breed the dog prior to having performed a satisfactory CERF eye exam and an OFA hip x-ray.

All dogs, regardless of show/pet purposes, shall carry the kennel name Red Forrest at the front of the name. You may fill in another kennel or phrase of your choice behind it.

Seller offers a 7-day money back guarantee. If the Buyer chooses to return this puppy to the Seller, he/she must do so within 7 days of the date of this agreement, guaranteeing the puppy is healthy and has not been exposed to any contagious diseases, as evidenced by a veterinarian's statement provided to the Seller if requested. The Seller will take back and rescue any dog of any age, if bred by Red Forrest with no cash or money back transaction. We stand behind our dogs and consider it our responsibility to accept back the dogs we have bred.

Said dog is hereby guaranteed to be in good health and free from any illness or disease for a period of 48 hours after purchase. If said dog should require veterinary attention with this period, Seller agrees to pay for all reasonable vet expenses upon receipt of a statement from attending veterinarian that the disease or illness was contracted or pre-existing prior to the 48-hour period. Seller demands to be notified immediately, should any illness or disease be detected so a decision may be made on how to proceed with the veterinary treatment. If the Seller is not notified within 24 hours, Seller is not obligated to any veterinary expenses. This guarantee DOES NOT extend to payment of veterinary attention for treatment due to negligence, mistreatment or accident to said dog, or for regular vet shots or exams. Seller guarantees said dog to be healthy on the "date of purchase", no breeder can guarantee the health and fitness of an animal for it's entire life.

Seller retains the right of first offer of purchase, should the Buyer decide to sell said dog at a later date. Purchase price shall be fair market value at the time of the sale.

If either party is forced to take legal action to enforce any part of this contract, action shall be initiated in the county of Seller's residence (San Diego, California), and any legal fees and court costs shall be the responsibility of the party found to be in default.

Seller states that any puppy is warranted only for the purpose of being a companion/pet animal. While it may be capable of performing other functions, no warranty is given as to its fitness for any special purpose. Further, Seller makes no warranty regarding loss of the puppy/dog, i.e., by accidental death, theft of the animal or sickness (except for health reasons as noted above). By signing this agreement, the Buyer certifies that he/she is not acting as an agent in this purchase; that the Buyer will not resell this puppy to a pet store, guard dog business or medical research facility.

Upon completion of titles: \$25 refunded upon completion first novice obedience, herding or agility titles through ASCA; \$50 refunded of first open obedience, herding, or agility titles through ASCA; A refund of \$100 for finishing an ASCA championship.
